In creating a Scholarship Fund, you invest in your community's future and show students you care. The Community Foundation for Southern Arizona provides expertise to help you meet your personal goals and awards scholarships to deserving students. Your gift can help students achieve their lifetime dreams.

How it works

- You make a gift to the Community Foundation for Southern Arizona. You can give cash, stocks, real estates or other assets.
- We set up a scholarship fund in your name, in the name of your family or business, or in honor of any person or organization you choose.
- You receive tax benefits in the year your gift is made.
- Our staff helps you to determine eligibility requirements for the scholarship you establish - whether they are based on field of study, academic achievements, extracurricular activities, or financial need
- We handle all the administrative details and award scholarships to students in the name of the fund you establish.
- Your gift can be placed into an endowment that is invested over time. Earnings from your fund are used to make award scholarships on a continuing basis. Your gift, and all future earnings from your gift, is a permanent source of community capital helping deserving students forever.

A couple of years into a comfortable retirement, Mr. and Mrs. Bruner, both former teachers, realized how much they missed making a difference in the lives of students.
