Founded in 2001, The Santa Cruz Community Foundation was created by area residents as a permanent resource for the entire county. Even though the Foundation has only been in existence for a few years, it has already compiled an impressive record of community service. In a recent grant year, in collaboration with the Ford Foundation, 16 local agencies received over \$54,000 in grant support and 38 local young people were awarded scholarships for \$143,240. We are an affiliate of the Community Foundation for Southern Arizona, the international Border Philanthropy Partnership and La Fundación del Empresariado Sonorense AC (FESAC), Sonora.
